

**Section 1.** That effective no later than January 1, 2021 fees charged to the public by the corresponding departments shall be as follows:

| (g) | \$500,001.00 to \$1,000,000.00  | \$4,000.00 for the first \$500,000.00 plus \$6.00 for each additional \$1,000.00, or a fraction thereof, to and including \$1,000,000.00 |
